REPORTS FROM THE STANDING COMMITTEES

Building and Architecture: Andy Leek, chair

The committee presented a request for a pergola in the back yard on existing patio at 10 Osage. Erik Manning made a motion to approve the pergola. Jim Taylor seconded, and the motion passed unanimously. The association requires the full board to review unattached buildings. Common Areas – Ryan Beevers, chair

The commons committee recommended applying for Edwardsville Neighborhood Enhancement, Recognition, and Grant Initiative (ENERGI) funds from Wards 5 and 6. The projects would be planting native flowers on the steep hill on Commons W1 near the kayak launch and stand and adding water tolerant plants on Commons B3. Donna Polinske made a motion to approve the application. Andy Leek seconded, and the motion passed unanimously.

The committee is shooting for a mid-month newsletter release and is available to support the silt committee in sharing updates on capital improvement projects as information becomes available.

Master Plan Implementation-Toby Heddinghaus, chair

Toby Heddinghaus went through a list of issues with current arrangements. A number of options have been considered but none seem to have wide-spread support. The board agreed to continue working the current process for assigning docks while looking into floating dock standards, ways to maximize space, and whether additional waivers or agreements are needed.
